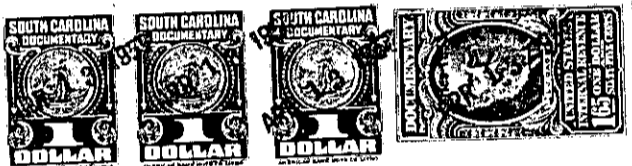

ALL that lot of land in Greenville County, South Carolina on the northern side of Jasmine Drive (formerly Douglas Street) known as Lot #8 of Grand View as shown by a plat made by Woodward Engineering Co., March, 1957, and having, according to said plat, the following metes and bounds:
