All that piece, parcel and lot of land in Gantt Township, Greenville County, State of South Carolina, near the City of Greenville, being known as Lot No. 43 BRANTFORD LANE according to a survey of South Forest Estates made August 29, 1955 by Pickell and Pickell, Engineers and recorded in the R.
