FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is GREENVILLE METALCRAFT CORPORATION

THIRD: That the principal place of business is on the Piedmont Highway, outside the city limits of Greenville, S. C.

FOURTH: That the general nature of the business which it is proposed to do is to manufacture and fabricate sheet metal products and other related items, and to purchase, mortgage, sell, lease and/or rent both real and personal property and to do all things generally allowed a domestic corporation by the State of South Carolina.
