ALL that piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina in Berea Community, being known and designated as LOT NO. 8 on plat of property of James H. Sutton and Inez H. Sutton according to a Survey made August 23, 1955 by Pickell & Pickell, Engineers and having the following metes and bounds, to wit:
