AN undivided one-half interest in and to all that parcel or tract of land situate lying and being near the North-Carolina - South Carolina State line, between Caesars Head, South Carolina, and Cedar Mountain, North Carolina, on the South side of the present Geer Highway and on the North side of old road from Caesars Head to Cedar Mountain, and being a portion of what is generally known as the Bradford tract, made by Howard Wiswall, C. E., 1918-1922, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "F", at Page 151, the following metes and bounds, to wit:
