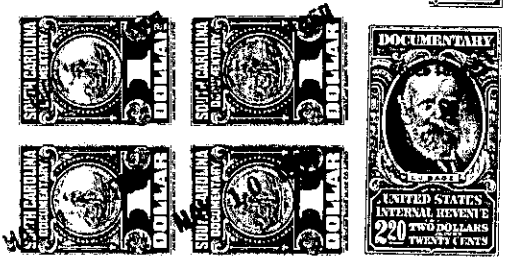
Know All Men by These Presents:

That I, Sarah Medlock in the State aforesaid, in consideration of the sum of \$10.00 and other valuable considerations DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Hazel Altom, her heirs and assigns:

ALL of my right, title and interest in that lot of land on Sullivan Alley (now known as Bolt Street) shown as Lot #5 on a plat of the Thomas M. Riley Estate made by J. Mac Richardson, December, 1946 and being known as house #7, according to said plat, and having, according to said plat, the following metes and bounds:
