

Reeves, Leonard Godfrey, Shelby Joains, Claude Neal and Billy Bryant, as Trustees for the Grace Baptist Church, their successors in office and assigns forever: IN TRUST NEVERTHELESS, for the Grace Baptist Church, Simpsonville, S. C. to hold said title in their names as Trustees of said Church for the benefit and in behalf of said church and to their successors in office to hold title likewise in trust for said church, their successors and assigns forever: nk bankloxtol xo secret escaig tarkika

All that lot of land situate, lying and being in the Woodside Mills Village, in the Town of Simpsonville, County of Greenville, South Carolina, and having according to a survey made by the Piedmont Engineering Service, dated February 1953, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the southwest corner of the intersection of First Street and an unnamed street, and running thence along the west edge of said unnamed street, S. 24-50 E. 175 feet to an iron pin; thence along line of other property of the grantor, S. 65-10 W. 175 feet to an iron pin; thence continuing along line of other property of the grantor, N. 24-50 W. 175 feet to an iron pin on the south side of First Street; thence with the south side of First Street, N. 65-10 E. 175 feet to the beginning corner.

The above described property is the same conveyed to the Trustees for the Church of God, Simpsonville, S. C. by Woodside Mills by its deed dated April 15, 1953 and recorded in the R. M. C. Office for Greenville County in Deed Book 476, at Page 385.

The Grantees assume and agree to pay the balance due on the note and mortgage given by the grantor to Franklin National Life Insurance Company dated August 10, 1954 in the principal amount of \$19,000.00, said mortgage being recorded in the R. M. C. Office for Greenville County in Mortgage Book 605, at Page 385, the balance due and owing being \$17,746.77.
