STEVENS & CO., INC. owning property and having a place of business at Greenville, Delaware in the State of South Carolina a corporation chartered under the laws of the State of Delaware in the State of South Carolina sum of One Thousand One Hundred Sixteen and 25/100ths (\$1,116.25) Dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto WILLIAM A. HAMMOND:

All that piece, parcel or lot of land situate, lying and being on the South-eastern side of Cottingham Street near Monaghan Mills, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 58 as shown on a plat entitled "Monaghan Subdivision, Greenville, S.C." made by Piedmont Engineering Service, Greenville, S.C., August 9, 1954, and recorded in the R.M.C. Office for Greenville County in Plat Book GG, at pages 86 and 87, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southeastern side of Cottingham Street at the joint front corner of Lots Nos. 57 and 58, and running thence with the line of Lot No. 57, S. 13-28 E. 122.8 feet to an iron pin in the rear line of Lot No. 49; thence with the rear line of Lots Nos. 49 and 48, N. 54-50 E. 66.6 feet to an iron pin; thence continuing with the rear line of Lot No. 48, N. 76-32 E. 36.3 feet to an iron pin at the joint rear corner of Lots Nos. 58, 59 and 48; thence with the line of Lot No. 59, N. 11-14 W. 97.1 feet to an iron pin on the Southeastern side of Cottingham Street; thence with the Southeastern side of Cottingham Street, S. 76-32 W. 100 feet to the point of beginning.

This conveyance is made subject to restrictive covenants applicable to Monaghan Subdivision recorded in the R.M.C. Office for Greenville County in Deed Book 509 at page 443, and to an easement for utilities service dated October 11, 1954, given by J. P. Stevens & Co., Inc. to Duke Power Company and recorded in the R.M.C. Office for Greenville County in Deed Book 510 at page 317.
