

 (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these
 presents do grant, bargain, sell and release unto the said L. A. Lingerfelt, Jr. & Helen P. Lingerfelt

all that piece, parcel or lot of land in Greenville Township, Greenville

County, State of South Carolina, known and designated as a portion of lot #127 of
 Newell Park Subdivision known as Plat #4 of same made by Dalton S.
 Newell, March 1945, recorded in the Greenville County R.I.C. Office in Plat
 Book 7, page 117, and according to said plat, more particularly described
 as follows:

Beginning at an iron pin on the north side of County Road, at
 south return corner of lot #127 shown on said plat and running thence
 N. 1-35 W. 70 ft. to iron pin corner of that portion of lot 127 sold to
 C. T. Brooks thence along line of C. T. Brooks lot in a westerly direction
 166 ft. more or less, to iron pin, which iron pin measures 75 Ft. N. 2-09
 W. from the southwest corner of lot #127; thence S. 2-09 E. 75 ft. to iron
 pin on the North side of said County road; thence along said road S. 88-47
 E. 1-0 ft. to the point of beginning.

The property herein conveyed is subject to the following restrictions:

1. That said land shall be used exclusively for residential purposes for white persons only and that the said land shall never be sold, rented, or otherwise disposed of to persons wholly or partly of African descent.
2. That no building shall be erected on said lot costing less than the sum of \$ 1,000.00.
3. That no building shall be erected nearer the front line of said lot than 70 ft. nor nearer than 10 ft. from either side line of said lot.
4. That no garage, closet nor sump pool shall ever be maintained on said land but only sanitary tanks or other sanitary sewerage.
5. That the grantor reserves to itself and its successors the right to authorize the placing, maintaining and repairing of any and all public utilities in this tract without compensation to any lot owner.
6. That no use of said lot which would constitute a nuisance to the adjoining lot owner.

This property is sold subject to the easement or right of way of The Duke Power Company crossing said property.
