ALL that lot of land in Greenville County, South Carolina on the northern side of Jasmine Drive (formerly Douglas Street) being known and designated as Lot #11 of Grand-View as shown on a plat made by Woodward Engineering, March, 1957, recorded in the Greenville County R. M. C. Office in Plat Book "KK" at page 93 and having, according to said plat, the following metes and bounds:

BEGINNING at the corner of Lot #10 on the northern side of Jasmine Drive and running thence with the northern side of Jasmine Drive, N. 71-10 E., 62 feet to a pin at the corner of Lot #12; thence with the line of Lot #12, N. 17-25 W., 150 feet to a pin in the rear line of Lot #22; thence with the rear lines of Lots #22 and #23, S. 72-35 W., 62 feet to a pin at the corner of Lot #10; thence with the line of Lot #10, S. 17-25 E., 150 feet to the point of beginning.
