Patton and running thence with the line of said property N. 59-28 W. 448 feet to a creek; thence with the meanders of said creek in an easterly direction 348 feet, more or less, to a point in line of other property of Alletta W. Jervey; thence with the line of said property S. 42-28 E. 257 feet to a stake on Jervey Road; thence with the curve of the northern side of Jervey Road, the chords of which are S. 24-37 W. 137 feet and S. 6-58 W. 113 feet to the beginning corner.
