Know All Men by These Presents:

That I, JOHN F. CHANDLER, in the State aforesaid, in consideration of the sum of ONE THOUSAND EIGHT HUNDRED SEVENTY AND NO/100 DOLLARS, (\$1,870.00) to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ARTHUR C. COOGLER, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 96 of a subdivision known as McSwain Gardens, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book GG at Page 75, and having the following metes and bounds, to wit:

BEGINNING at a point on the Eastern side of McSwain Drive at the joint front corner of Lots 95 and 96 and running thence N 67-37 E 175.3 feet to a point at the joint rear corner of Lots 95 and 96; thence S 22-10 E 94.6 feet to a point at the joint rear corner of Lots 96 and 97; thence S 67-37 W 168.1 feet to a point on the Eastern side of McSwain Drive at the joint front corner of Lots 96 and 97; thence with the Eastern side of McSwain Drive N 28-46 W 63 feet to a point; thence continuing with the Eastern side of McSwain Drive N 22-23 W 32 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s)' Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s)' Heirs and Assigns against the grantor(s) and the grantor's(s)' Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
