ALL those lots of land, situate on the Northwest side of Nottingham Road, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 184 and Lot No. 186, on plat of Sherwood Forest, made by Dalton & Neves, Engineers, August, 1951, revised through December, 1952, recorded in the RMC Office for Greenville County, S. LOT 186, begins at the joint front corner of Lots 185 and 186, and running thence with the line of Lot 185, N. 20-17 W., 187.8 feet to an iron pin; thence N. 74-04 E., 60.2 feet to an iron pin; thence N. 62-46 E., 15.1 feet to an iron pin; thence with the line of Lot 187, S. 20-17 E., 185.1 feet to an iron pin on the Northwest side of Nottingham Road; thence with Nottingham Road, S. 69-43 W., 75 feet to the beginning corner.

Lot 186 above described is conveyed subject to the drainage easement along the Northeast side of said lot, 5 feet in width, as shown by the recorded plat referred to above.
