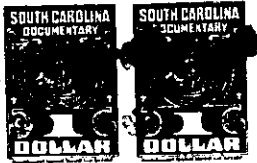

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Glenn Cooper, His heirs and assigns forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, in Paris township, being known and designated as Lot No. 107 as shown on a Plat of Section 2, Bellwood Estates, dated 1955 by Woodward Engineering Company, recorded in the R. M. C. Office for Greenville County in Plat Book GG, at Page 50, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Bellwood Road at joint front corners of Lots 106 and 107 and running thence along the line of said lots, N. 73-16 W. 120 feet to iron at rear corner of Lot 105; thence running with rear line of said lot, N. 28-48 W. 114.2 feet to iron pin at rear corner of Lot 108; thence running with rear line of said lot S. 73-16 E. 201.5 feet to iron pin on Bellwood Road; thence running with said Road S. 16-44 W. 80 feet to iron pin at point of beginning.

NO residence shall be built on any lot costing less than \$ 7,500.00 Dollars; no residence shall be built on said lots nearer than 25 feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks,

THIS property is sold subject to the rights of way to Duke Power Company.

GRANTEE to pay taxes for the year 1957.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.
