That Derby Heights Inc., a corporation in the State aforesaid, in consideration of the sum of TWO THOUSAND AND NO/100----- DOLLARS,

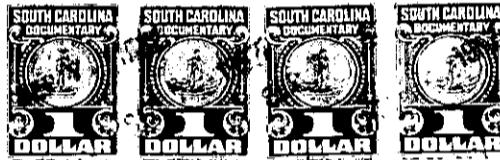

All that piece, parcel and lot of land in Gantt Township, Greenville County, State of South Carolina, near the City of Greenville, being known as Lot No. 320 according to a survey of Belle Meade Subdivision(Section 3) made by Piedmont Engineering Service and recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "GG" at Page 187. Said lot fronts on Pine Creek Drive and is more particularly described as follows:
