All that lot of land in the county of Greenville, state of South Carolina, near the city of Greenville, being known and designated as Lot No. 15 of Block D, on plat of Brookforest recorded in plat book BB pages 40 & 41 of the RMC Office for Greenville County, and having according to a recent survey made by R. E. Dalton, March 1956, the following metes and bounds, courses and distances to-wit:

Beginning at an iron pin on the southwest side of Woodmont Circle, the front joint corner of Lots Nos. 14 & 15; thence with the joint line of said lots S. 10-11 W. 198.4 feet to an iron pin; thence S. 88-06 W. 110.4 feet to an iron pin; thence continuing S. 88-06 W. 14 feet to a point in a branch; thence with said branch as the line N. 4-22 W. 103 feet to a point in said branch, corner of Lot No. 16; thence with the line of said lot N. 36-07 E. 6 feet to an iron pin; thence continuing with the line of said lot N. 36-07 E. 149.7 feet to an iron pin on the southwest side of Woodmont circle; thence with the southwest side of Woodmont Circle, the chord of which is S. 68-38 E. 70 feet to the beginning corner.

Being the same lot conveyed to grantor by Donald E. Baltz by deed recorded May 10, 1956 in volume 552 page 188 of the RMC Office for Greenville County, and is conveyed subject to building restrictions applicable to Brookforest recorded in deed book 476 page 153.

The grantee herein assumes and agrees to pay that certain mortgage held by Metropolitan Life Insurance Company (assigned to them by C. Douglas Wilson & Co.) recorded May 10, 1956 in mortgage volume 677 page 431 on which there is a balance due of \$13,243.62.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

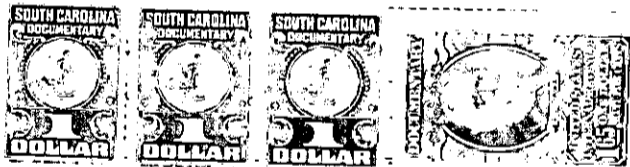
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.
