James M. Griffith and Hilda D. Griffith, their heirs and assigns forever:

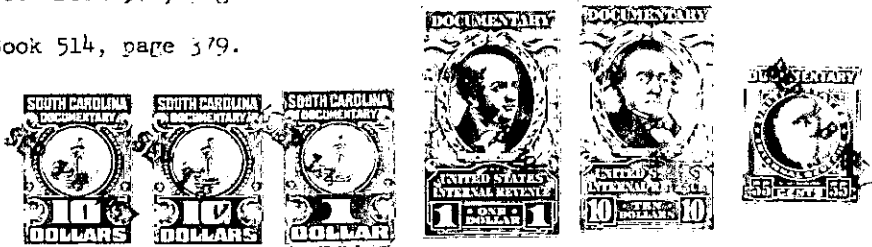

BEGINNING at an iron pin on the easterly side of Bear Grass Drive at a point 50.7 feet north of the northeasterly corner of the intersection of said Drive with Two Notch Road, said pin being the joint front corner of Lots Nos. 43 and 44, and running thence along the easterly side of Bear Grass Drive N 14-46 E 75 feet to an iron pin, joint front corner of Lots Nos. 44 and 45; thence along the joint line of said lots S 75-14 E 215.1 feet to an iron pin; thence S 24-46 W 76.15 feet to an iron pin, joint rear corner of Lots Nos. 43 and 44; thence along the joint line of said lots N 75-14 W 211.9 feet to the point of beginning.
