D. Harrell, Jr. and Eunice C. Harrell, their heirs and assigns:**

All our undivided interest in and to that certain piece, parcel and lot of land situate lying and being in Chick Springs Township, Greenville County, South Carolina, designated as Lots # 15 and 16 on Map # 2 of Audubon Forests prepared by C. O. Riddle during January 1955 and recorded in the R.M.C. Office for Greenville County in Plat Book "BB" at page 167 and having according thereto the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Audubon Road at the joint front corner of Lots # 16 and 17, and running thence along said road S. 88-55 E. 145.6 feet to an iron pin; thence S. 74-52 E. 74.4 feet to an iron pin at the joint front corner of Lots # 15 and 16; thence S. 61-08 E. 89.2 feet to an iron pin; thence S. 42-39 E. 64.5 feet to an iron pin; thence S. 23-52 E. 176.1 feet to an iron pin; thence S. 29-42 E. 69.7 feet to an iron pin; thence S. 35-14 E. 67.3 feet to a point at the joint front corner of Lots # 14 and 15; thence along the line of Lot # 14 S. 24-10 W. 195 feet to an iron pin on a branch; thence up said branch as the line in a Northwesterly direction 359.1 feet, more or less, to the joint rear corner of Lots # 16 and 17; thence along the line of Lot # 17 N. 7-30 W. 484.8 feet to the point of BEGINNING.
