County, State of South Carolina, near the City of Greenville and near the Bram-  
lette Road, on northern side of Arch Street Extension, and being known  
and designated as Lot Number Three (No. 3) on a plat of the F.B. Massin-  
gale property made by J. Coke Smith & Son, May 15, 1947, and, according to  
said plat, having the following metes and bounds, to-wit:  
BEGINNING at a point on northern side of Arch Street Exten-
