signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is SOUTHEASTERN SURGICAL CC.

THIRD: That the principal place of business is GREENVILLE, S. C.

FOURTH: That the general nature of the business which it is proposed to do :s

To purchase, lease or otherwise acquire and to hold, own, sell, mortgage, pledge or otherwise dispose of, to invest, trade and deal in, real and personal property of all kinds and in particular to sell, improve, manage, develop or lease to make contracts and incur liabilities, borrow money, issue notes, bonds and other obligations and secure any of its obligations by mortgage or pledge of any or all of its property. To lend money for its corporate purposes, invest its funds in the late to time, and take and hold real property and tangible and intimities personal property as security for the payment of funds so longer or invested. To acquire by purchase, subscription or otherwise, and to own, hold, sell, assign, transfer, mortgage, pledge, exchange or otherwise dispose of, and to deal in and deal with shares of capital stock, bonds, debentures, obligations, evidences of indebtedness and securities issued by any public or private corporation, government or municipality, or otherwise, and other property, real and personal, and to pay cash therefor or to issue in exchange therefor the shares of capital stock, bonds, notes, debentures or obligations or evidences of indebtedness of the corporation.

To buy, sell and deal in, either at wholesale or retail, all variety of supplies and equipment for hospitals; to manufacture, become vendors, distributors and jobbers of all types of hospital and institutional supplies, pharmaceuticals and equipment as well as supplies and institutional supplies, pharmaceuticals and equipment as well as supplies and equipment of every nature and kind employed in the medical profession; to likewise buy, sell and otherwise deal in all supplies, equipment and other articles employed by and used in hotels, homes, schools, colleges, sanitariums and other institutions; and to do any and all other things necessary and incidental to the carrying out of said business. To purchase, take, receive, or otherwise acquire, hold, own, pleage, transfer or otherwise dispose of its own shares. To do all and everything necessary, suitable, or proper for the accomplishment of any of the purposes, the attainment of any of the objects or the furtherance of any of the powers hereinabove set forth, either alone or in connection with other corporations, firms or individuals and either as principals, or agents, and to do every other act or acts, thing or things, incidental or appurtenant to or growing out of or connected with the aforesaid objects, purposes or powers or any of them. The foregoing enumeration of specific powers shall not be deemed to limit or restrict in any manner the general powers of the corporation, and the enjoyment and exercise thereof, as conferred by the laws of the State of South Carolina upon corporations.
