

Willie Rae S. Hughes, their heirs and assigns forever:

Township, Greenville all that piece, parcel or lot of land in Chick Springs

County, State of South Carolina, Tax District 265, located on the West side of Miller Drive and being knewn as lots SIX (6) and SEVEN (7) on a plat of property entitled "Fleming Heights" made by Robert Jordan, surveyor, dated September 27, 1957 and recorded in plat book KK page 113, Greenville County R. M. C. Office and having the following metes and bounds,

All my right title and interest in that piece of property lying between lot number seven and the J. P. Hughes and Eula W. Hughes lot (see deed to Hughes recorded in deed book 509 page 353, Greenville County R. M. C. Office and having the fellowing courses and distancesto wit: Beginning at the corner of the Hughes lot and running thence S. 66800 W. around 224.5 feet; thence S. 76-16 E., 63.3 feet; thence N. 61-41 E., 210.6 feet to the corner of the Hughes lot and a point on the West side of Miller Drive.
