Annie Howell, her Heirs and Assigns forever,

All of my right, title and interest (a one-half undivided interest) in and to ALL that certain piece, parcel or tract of land situate, lying and being in the State and County aforesaid, Oneal Township, about one mile east of Mt. Lebanon Baptist Church, lying on the south side of the Jordan Road, being shown and designated as Lot. No. 2 on a plat of property of BYRD AND ANNIE HOWELL made by H. S. Brockman, Surveyor, August 20th 1957, and having the following courses and distances, to wit:-

Beginning on a nail and cap in the center of the said Jordan Road, joint corner of the Paul Sloan tract, and runs thence with the said road, S.69-00 E. 175 feet to a point in the said road and joint corner of the former J. B. Henson tract; thence with the former J. B. Henson line, S, 4-43 W. 1455 feet to a stake, joint corner of a tract now or formerly of C. B. Howell; thence with the line of this tract, N. 82-30 W. 1277 feet to a stake; thence N. 3-45 E. 293 feet to a stake; thence N. 59-15 E. 96.4 feet to a stake at or near an old spring place, joint corner of the Paul Sloan tract; thence with the Paul Sloan line, N. 47-43 E. 284.5 feet to a stake in a waterway, Sloan's corner; thence with the said waterway, N. 55-00 E. 999 feet to a stake in the said waterway; thence leaving the said waterway, N. 23-30 E. 245 feet to the beginning corner, containing Twenty Six and Seventy Six One-hundredths (26.76) acres, more or less.
