M. C. Office for Greenville County in Plat Book S, at page 195 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Carolina Avenue at the joint front corner of Lots Nos. 13 and 14; which iron pin is situate 758.1 feet south west from the intersection of Carolina Avenue and Laurel Greek Lane, which iron pin is situate in the center of a 4 foot ditch, S. 19-46 E. 140 feet to an iron pin, rear corner of Lots Nos. 13 and 14, said pin being in the middle of said 4 foot ditch; thence S. 87-14 W. 69.6 feet to an iron pin; joint rear corner of Lots Nos. 14 and 15; thence with the line of Lot No. 15, N. 14-0 W. 126.3 feet to an iron pin on the southern side of Carolina Avenue, joint front corner of Lots Nos. 14 and 15; thence with said avenue, N. 76-34 E. 54.1 feet to the point of beginning.

As part of the consideration for the within conveyance the grantees assume the mortgage on the above described property given by the grantor to C.
