That certain tract or parcel of land, with any improvements thereon, in Butler Township, said County and State, located about seven miles from Greenville, and designated as Tract #1 on plat of the Walter Wilson Estate, prepared by H.S. Brockman, 11-13-51, and delineated thereon as follows:
