All that piece, parcel or lot of land in Greenville Fownship, Greenville County, State of South Carolina, with the buildings and improvements thereon, being in the corporate limits of the City of Greenville in that section known as "yest Greenville" on the north side of the Old Pendleton Road, (known as Pendleton Street now) being a portion of Lots 11, 12, 13 and 14 as shown on plat of subdivision as "Providence," which plat is recorded in the ". M. C. Office for Greenville County in Plat Book A, at page 411, and having according to a survey and plat entitled "Property of Charles A. Denton," prepared by R. D. Neves, Reg. Fng., in Tovember, 1940, the following metes and bounds, to-wit:

BEGINNING at an X mark on the pavement on the north side of old Pendleton Road, (known now as Pendleton Street), at the corner of property now or formerly of belown and which point is 149 feet in a westerly direction from the northwest intersection of the Old rendleton Road and Loodside Avenue; and running thence along the said beloom line and partly through the center of a brick wall, 1. 4-30 7. 79 feet to an iron pin on property now or formerly of Houston; thence along line of Houston, S. 95-30 W. 40 feet to an iron pin on the east side of a 9-foot alley; thence along the east side of said alley, S. 4-30 W. 77 feet to an X mark on the pavement at the northeast intersection of said 9-foot alley with the Old Fendleton Road; thence along the north side of the Old Fendleton Road, S. 95-30 E. 11 feet to an X mark or the pavement; thence continuing along the north side of said road, ... 95-30 E. 29 feet to point of beginning.
