to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Amos F. Parker, his heirs and assigns, a total of one-third of the herein- after described property, so that he shall share equally with each of the grantors.

All that piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, lying and being on Enoree River, containing 55 acres, more or less and having the following metes and bounds, to wit; according to plat made by W. A. Adams, surveyor, dated February 25, 1918.

BEGINNING at an iron pin on Enoree River and running thence N. 65 1/2 W. 11.21 chs. with line of land now or formerly owned by R. C. Slatten to an iron pin in middle of planation road; thence N. 40 E. 2.11 chs. to iron pin in center of said road, the road being the line; thence N. 32 W. 1.94 chs. to iron pin; thence N. 80 5/6 E. 7.00 chs. to iron pin; thence N. 9 1/2 W. 5.00 to an iron pin on Enoree River; thence down the meanders of said river to the point of beginning. Said premises being the same conveyed to the grantors by deed dated October 28, 1944, recorded in the R.M.C. Office for Greenville County in Book 268, Page 397.
