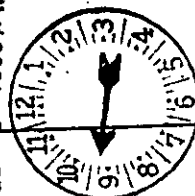

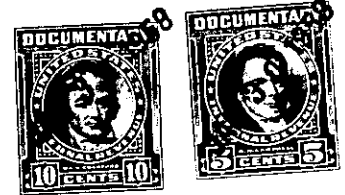


KNOW ALL MEN BY THESE PRESENTS, that FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION

granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the said  
Grantee and unto his successors in such office, as such, and his or their assigns, the following-described property  
situated in the county of Greenville, South Carolina, to wit:

All that certain piece, parcel or lot of land in the State of South Carolina,  
County of Greenville, near the Donaldson Air Base, and being known and designated  
as Lot No. 29 of a subdivision known as Springview, a plat of which is of record in the  
R.M.C. Office for Greenville County in Plat Book BB, at Page 161, and having,  
according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the Southern side of Farley Avenue at the joint front  
corner of Lots Nos. 29 and 30, and running thence S. 1-06 E. 176.5 feet to a point;  
thence S. 89-23 E. 63 feet to a point; thence N. 1-06 W. 175.4 feet to a point  
on the Southern side of Farley Avenue; thence with the Southern side of Farley  
Avenue, N. 88-10 W. 57.6 feet to a point; thence continuing with the Southern side  
of Farley Avenue, S. 88-54 W. 5.4 feet to the point of beginning.



Together with all and singular, the improvements thereon and the rights, members, hereditaments, and appur-  
tenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular, the property herein granted and transferred unto the said  
Grantee and unto his successors in such office, as such, and his and their assigns, forever.
