J. E. Meadors, his heirs and assigns forever:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 76, according to Plat of Section 1 of Lake Forest, which plat is recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book "GG", Page 17, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northerly side of Lake Fairfield Drive, joint front corner Lots 76 and 77, and running thence N. 38-43 W. 176.3 feet to an iron pin, joint rear corner Lots 76 and 77; thence S. 59-09 W. 83.9 feet to an iron pin, joint rear corner Lots 75 and 76; thence S. 29-25 E. 191 feet to an iron pin on Lake Fairfield Drive, joint front corner Lots 75 and 76; thence along Lake Fairfield Drive N. 51-41 E. 110 feet to an iron pin, the point of beginning.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

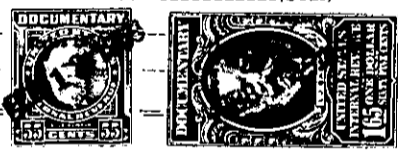
