of Greer, S. C., lying on the north side of State Highway No. 14 and on
the eastern side of the Mt. Lebanon Road, being bounded on the north by
the Ballenger Road and lands formerly of Mrs. P. L. Bruce, on the east
by lands of J. H. Gibson Estate, on the south and east by lands of H. C.
