Know All Men by These Presents:

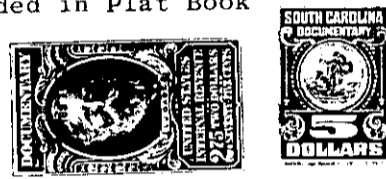

COURTNEY P. HOLLAND, his heirs and assigns forever,

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, in Greenville Township, being known and designated as LOT NO. 24 on Birchwood Drive and being shown on plat of Subdivision known as KIRKWOOD HEIGHTS according to a Survey made by Pickell & Pickell, Engineers in October 1954 and recorded in the RMC Office for Greenville County in Plat Book EE, at pages 110 and 111 and having the following metes and bounds, to wit:

BEGINNING at an iron pin at the joint front corner of Lots 23 and 24 on Birchwood Drive and running thence along the joint line of said lots, South 17-56 East 150 feet to an iron pin; running thence South 72-04 West 80 feet to an iron pin; running thence North 17-56 West 150 feet to an iron pin on Birchwood Drive; running thence along Birchwood Drive, North 72-04 East 80 feet to the point of beginning.
