All that piece, parcel or lot of land in the County of Greenville, state of South Carolina, designated as Lot No. 13, Block "C", on a revised plat of a portion of Block "C" of BROOKFOREST subdivision, made by Dalton & Neves, November 1956, recorded in Plat Book LL page 118 of the RMC Office for Greenville County, S. C., and having according to said plat and a recent survey made by R. W. Dalton, February 1957, the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the southwest side of Westbrook Lane, the front joint corner of Lots Nos. 13 and 14; thence with the joint line of said lots, S. 43-39 W. 183 feet to an iron pin in line of Lot No. 20; thence with the line of said lot, S. 54-05 E. 48 feet to an iron pin, corner of Lot No. 12; thence with the line of said lot, N. 55-42 E. 175 feet to an iron pin on the southwest side of Westbrook Lane; thence with the southwest side of said Westbrook Lane, N. 42-53 W. 85 feet to the beginning corner.

This is the same property conveyed to grantor by Donald E. Baltz by deed dated March 2, 1957 recorded in volume 572 page 253 of the RMC Office for Greenville County.
