RUTHERFORD, his heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon, situate on the East side of West Dorchester Boulevard, near the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot 123 on Plat of Section 1 and 2 of Belle Meade Subdivision, made by Piedmont Engineering Service, June, 1954, recorded in the RMC Office for Greenville County, S. C., in Plat Book GG, page 95, and having according to said plat the following metes and bounds, to wit:
