to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. G. Davis and Nettie O. Davis, their Heirs and Assigns, forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, known and designated as lot 6, Section C, Englewood Estates, as shown by a plat thereof dated December 1951, recorded in the R. M. C. Office for Greenville County in Plat Book BB at page 13, and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the southeast side of Fairfield Road, joint front corners of lots 5 and 6 and running along Fairfield Road S. 81-43 W. 80 feet to an iron pin, joint front corners of lots 6 and 7; thence along the common line of lots 7 and 6 S. 27-30 E. 182.9 feet to an iron pin in the line of lot 8 and joint rear corners of lots 7 and 6; thence with the line of lots 8 and 6 N. 88-57 E. 45.5 feet to an iron pin in the line of lot 8 and at joint rear corners of lots 6 and 5; thence along the common line of lots 5 and 6 N. 15-54 W. 180.5 feet to an iron pin on Fairfield Road, the point of beginning.

Restrictions: The above described property is not to be sold, rented or otherwise disposed of to any Negro or person of African descent. No residence shall be built at less than \$5,000.00. No residence shall be erected on said lot unless it have 50 feet or more frontage. No house is to be built nearer than 50 feet to the front line. No temporary house shall be erected on said lot.

GRANTEES herein to pay taxes for the year 1957.

This property is conveyed subject to any rights of way now in existence.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

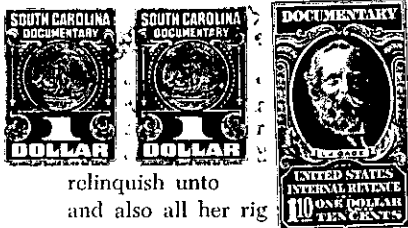
