PARCEL #2

ALL that lot of land in Greenville Township, Greenville County, State of South Carolina situated on the south side of East North Street Extension, being designated as Lot No. 2 of the property of George Norwood, as shown on plat of said property made November, 1928, by W. M. Rast, Engineer, and being a part of Lot No. 52, of the Overbrook Subdivision, as shown on plat of said subdivision recorded in the R. M. C. Office for Greenville County in Plat Book "E", at page 252, and having the following metes and bounds:

BEGINNING at an iron pin on the south side of East North Street Extension, 60 feet east from corner of Lot No. 50 of the Overbrook Subdivision, as shown on plat recorded in Plat Book "E", at page 252, and running thence S. 8-06 E., 200 feet to an iron pin; thence N. 76-07 E., 58.6 feet to an iron pin; thence N. 7-41 W., 200 feet to an iron pin on the south side of East North Street Extension; thence with said street, S. 76-07 W., 60 feet to the beginning corner.

BEGINNING at a point on the south side of Sullivan Street, 490 feet west from the southwest corner of the intersection of Sullivan and Augusta Streets, joint corner of Lots Nos. 6 and 7, and running thence along Sullivan Street, N. 88-25 W., 60 feet to a point, joint corner of Lots Nos. 7 and 8; thence along the joint line of Lots Nos. 7 and 8, S. 0-23 W., 160 feet to a point, joint rear corner of Lots Nos. 7 and 8; thence S. 88-25 E., 60 feet to a point, joint rear corner of Lots 6 and 7; thence N. 0-23 E., 160 feet to the point of beginning.
