Edens, in the State aforesaid, in consideration of the sum of Five Thousand Two Hundred Fifty and No/100 (\$5,250.00) DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Henry Clay Blackwell and Betty T. Blackwell, their heirs and assigns forever:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. 4 of property of J. R. Stevens shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "L", Page 73, and having according to said plat the following metes and bounds to-wit:

BEGINNING at an iron pin on the eastern side of a Private Road leading to the Anderson Road and at the joint front corner of Lots Nos. 4 and 5; and running thence along the line of Lot No. 5 N. 51 E. 356 feet to an iron pin in the line of property now or formerly belonging to C. G. Gunter, Inc.; thence along Gunter line N. 53 and 1/8 W. 80 feet to an iron pin at the joint corner of Lots Nos. 1 and 4; thence along the rear line of Lots Nos. 1, 2 and 3 S. 51 W. 311.5 feet to an iron pin on the eastern side of the Private Road above referred to; thence along said Private Road S. 22 and 3/4 E. 80 feet to the beginning corner.
