All that lot of land in the County of Greenville, State of South Carolina, known and designated as Lot No. 19 on plat of PINE BROOK EXTENSION, recorded in Plat Book W, page 73, and a rear portion of Lots Nos. 11 and 12, Block E, on plat of Mayfair Estates, recorded in Plat Book S, pages 72 and 73 of the R.M.C. Office for Greenville County, S. C., and having according to said plat, and a recent survey made by R. W. Dalton, R. E., April 1958, the following metes and bounds, courses and distances, to wit:

BEGINNING at an iron pin on the northern side of Runyon Drive, the front joint corner of Lots Nos. 19 and 20 of Pine Brook Extension; thence with the joint line of said lots, N. 11-38 W. 140 feet to an iron pin in Lot No. 11 of Mayfair Estates; thence across Lots Nos. 11 and 12 of Mayfair Estates, 5. 68-04 W. 72.3 feet to an iron pin in line of Lot No. 13; thence with the line of said lot, S. 21-56 E. 25 feet to an iron pin; rear corner of Lot No. 13; thence with rear line of Lots Nos. 13, 14 and 15 of Mayfair Estates, S. 68-04 W. 92 the rear line of iron pin in branch; thence S. 22-18 E. 14 feet to an iron pin on the northern side of Runyan Driver northern side of Runyon Drive; thence with the northern side of Runyon Drive, s. 86-58-2. 160 feet to the beginning corner.
