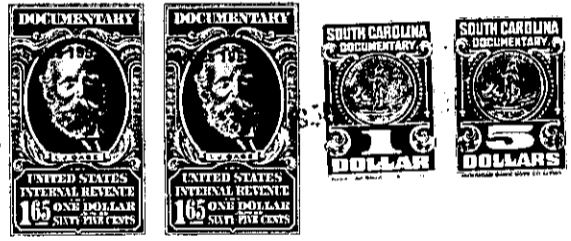

C., for and in consideration of the sum of Two Thousand Nine Hundred Fifty and No/100ths (\$2,950.00)-----dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto A. RAYMOND ANDREWS AND ALICE K. ANDREWS:

All that certain piece, parcel or lot of land situate, lying and being on the Southerly side of Roe Ford Road (S.C. Highway No. 88), in Pafis Mountain Township, near the City of Greenville, in Greenville County, State of South Carolina, being known and designated as the Westerly portion of Lot No. 57 of a subdivision known as Stratford Forest and having according to a plat of said subdivision prepared by Piedmont Engineering Service, dated February 25, 1957, and recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book KK at page 89, and also according to a more recent plat prepared by Piedmont Engineering Service, dated January, 1957, the following metes and bounds:

BEGINNING at an iron pin on the Southerly side of Roe Ford Road (S.C. Highway No. 88) at the joint front corner of Lots Nos. 57 and 58, and running thence with the line of Lot No. 58 S. 12-25 W. 295.5 feet to an iron pin in the rear line of Lot No. 48; thence with the rear line of Lot No. 48 S. 74-08 E. 102.2 feet to an iron pin in the rear line of Lot No. 57; thence a new line through Lot No. 57 N. 13-00 E. 297.4 feet to an iron pin on the Southerly side of Roe Ford Road (S.C. Highway No. 88); thence with the Southerly side of Roe Ford Road (S.C. Highway No. 88) N. 75-40 W. 103.1 feet to the point of beginning.

This conveyance is made subject to "Protective Covenants Applicable to Stratford Forest" recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 578 at page 1, and to drainage and utility easements, if any, affecting said lot.

This is a portion of the property conveyed to the grantor herein by deed of Furman University, dated November 13, 1956, and recorded in the Office of the R.M.C. for Greenville County, South Carolina, in Deed Book 567 at page 397.

To have and to hold all and singular the premises before mentioned unto the grantee(s) hereinabove named, their heirs and assigns forever.  
And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and their heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
