That I, M. W. Fore in the State aforesaid, in consideration of the sum of One Hundred Fifty & NO/100 (\$150.00) - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Everette Pigg and Claire M. Pigg, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Chick Springs Township, being known and designated as Lot No. 64 of a subdivision known as Holly Vista, as shown by a Plat thereof, dated February 1956, recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 191, and having according to said Plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Millervale Road at joint front corners of Lots Nos. 63 and 64 and running thence along the line of said lots, N. 44-48 E. 181.2 feet to iron pin; thence running, S. 25-30 E. 53.1 feet to iron pin at rear corner of Lot 65; thence running with line of said lot, S. 44-48 W. 149.4 feet to iron pin on Millervale Road; thence running with said Road, N. 61-05 W. 52 feet to iron pin at point of beginning.

NO residence to cost less than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on said lots; no residence shall be erected on any lot unless said lot has fifty (50) feet or more, frontage; no residence shall be built on any lot nearer than thirty (30) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS deed is made subject to all easements and rights of way of record. GRANTEE to pay taxes for the year 1958.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.
