All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the southerly side of Forestdale Drive, near the City of Greenville, S. C., being shown as Lot No. 59 on the plat of Forestdale Heights as recorded in the RMC Office for Greenville County, S. C. in Plat Book KK, page 199, and having according to said plat the following metes and bounds, to-wit:
