WHEREAS,

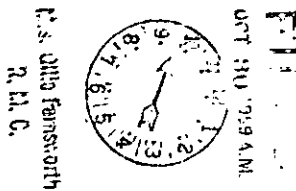
did on the 28th day of October, 1959, file with the Secretary of State a written Declaration, signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is SECURITY DISCOUNT CORPORATION OF GREENVILLE

THIRD: That the principal place of business is 21 College Street, GREENVILLE, S. C.

FOURTH: That the general nature of the business which it is proposed to do is to buy and sell, at wholesale and retail, to lend money and to buy, sell and deal in notes, bonds, stocks, chattel mortgages, real estate mortgages and any and all other types of securities and credit instruments and to buy, sell, hold and lease real estate and any and all types of personal property; to build, construct, equip and lease warehouses, store buildings and any and all other buildings of every type and nature and to do any and all things in any wise connected with the foregoing.



FIFTH: That the amount of the capital stock is Twenty-five Thousand (\$25,000.00)----- Dollars payable in money, chattels and goods.

SIXTH: That the number of shares into which the capital stock is divided is Twenty Five Thousand (25,000) of the par value of One (\$1.00)----- Dollars.

SEVENTH: That, after due notice, a meeting of the subscribers was held on the 27th day of October, 1959, at which a majority of all stock in value being present in person or by proxy, the following were elected directors: J. L. Bridges, John E. Bomar, Scott C. Taylor, W. A. Lundy, T.E. Walsh, Mike S. Jolly and James P. Gray

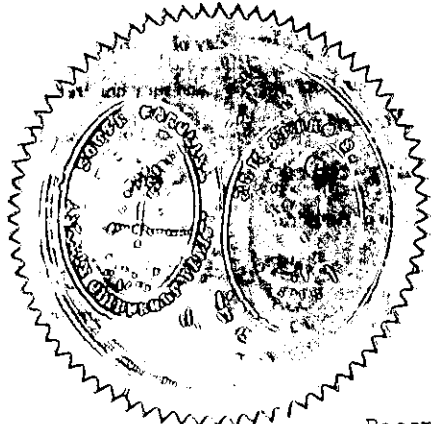
EIGHTH: That subsequently there was elected as President, J. L. Bridges ; as Vice-President, John E. Bomar ; as Secretary, John E. Bomar ; as Treasurer, J. L. Bridges

NINTH: That all requirements of Title 12, Article 1, Chapter 2, Code of Laws of South Carolina, 1952, and all amendments thereto have been duly and fully complied with, 50 per cent. of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent. of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in The Greer Citizen a newspaper published in the County of Greenville

NOW, THEREFORE, I, O. FRANK THORNTON, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said Company has been fully organized according to the laws of South Carolina, under the name and for the purposes indicated in their written declaration, and that they are fully authorized to commence business under their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance or Clerk of Court in each county where such Corporation shall have a business office.
