KNOW ALL MEN BY THESE PRESENTS, that we, George H. Lindsey, Albert P. Jones and Alvin E. Smith,

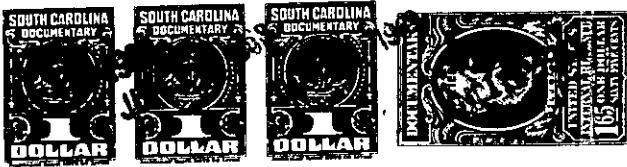
in consideration of Fourteen Hundred Ninety Five and No/100----- Dollars,
