release unto William F. Davis and Minnie R. Davis

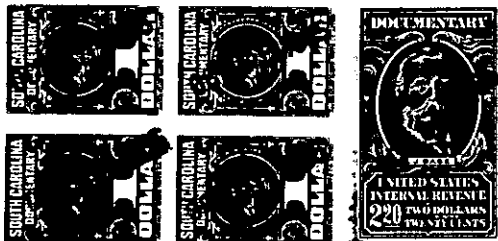
