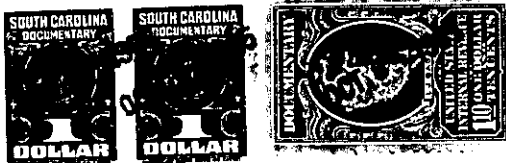
In consideration of One Thousand and No/100 (\$1,000.00)----- Dollars,

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the southern side of Selwyn Drive and being known and designated as Lot No. 35 of Timberlake as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "BB", at Page 185 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Selwyn Drive at the joint front corner of Lots Nos. 34 and 35 and running thence along the joint line of said lots S. 18-28 E. 188 feet to an iron pin; thence N. 34-38 E. 68.2 feet to an iron pin; thence N. 7-04 E. 148.9 feet to an iron pin; thence along the southern side of Selwyn Drive as follows: S. 83-41 W. 57.9 feet to an iron pin; S. 72-49 W. 48 feet to an iron pin; S. 68-21 W. 14.1 feet to an iron pin, the point of beginning.
