ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot No. 73 as shown on a Plat of Valencia Estates by W. N. NO residence to cost less than \$10,000.00 shall be erected on any lot; no residence shall be erected on lots nearer than 35 feet to the front line; no residence shall be built on any lot unless said lot has 70 feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by septic tanks; all lots to be used for residential purposes only.
