All that lot of land in the city of Greenville, Greenville County, state of South Carolina, shown as Lot No. 413 on plat of Section D of Gower Estates, made by R. K. Campbell and Webb Surveying & Mapping Co., May 1964 recorded in the RMC Office for Greenville County, S. C., in Plat Book RR at pages 192 and 193, and having, according to said plat the following metes and bounds, to-wit:
