

All that lot of land in the city of Greenville, Greenville County, state of South Carolina, shown as Lot No. 413 on plat of Section D of Gower Estates. made by R. K. Campbell and Webb Surveying & Mapping Co., May 1964 recorded in the RMC Office for Greenville County, S. C., in Plat Book RR at pages 192 and 193, and having, according to said plat the following metes and bounds. to-wit:

Beginning at an iron pin on the west side of Pimlico Road at the joint front corner of Lots 412 and 413 and runs thence along the line of Lot 412, S. 75-56 W. 175 feet to an iron pin; thence N. 14-04 W. 110 feet to an iron pin; thence with the line of Lot 414, N. 75-56 E. 175 feet to an iron pin on the west side of Pimlico Road; thence along Pimlico Road S. 14-04 E. 110 feet to the beginning corner.
