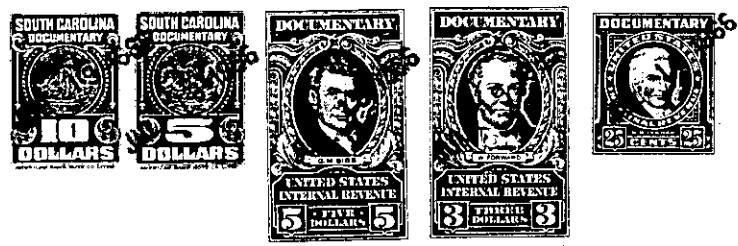
KNOW ALL MEN BY THESE PRESENTS, that W.N. Leslie, Inc.
