Emberson, KNOW ALL MEN BY THESE PRESENTS, that in consideration of Twenty-One Hundred and No/100 (\$2100.00)---Dollars, and assumption of mortgage referred to below the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, unto sell and release Charles K. Jacobs and Wanda M. Jacobs, their heirs and assigns forever: All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina on the southeastern side of Montis Drive (formerly Paris View Drive) being known and designated as Lot No. 13, Paris View Subdivision, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book "QQ" ', at Page 26 and having, according to said plat, the following metes and bounds, to-wit: BEGINNING at an iron pin on the southeastern side of Montis Drive (formerly Paris View Drive), joint front corner of Lots Nos. 13 and 14 and running thence with the common line of said lots S. 70-54 E. 175 feet to an iron pin; thence across the rear line of Lot No. 13 S. 19-06 W. 82 feet to an iron pin; thence with the common line of Lots Nos. 12 and 13 N. 70-54 W. 175 feet to an iron pin on the southeastern side of Montis Drive; thence with said Drive N. 19-06 E. 82 feet to an iron pin, the point of beginning.
