ALL that lot of land in Greenville County, South Carolina known and designated as Lots Number One and Two (1 and 2) of Section Two (2) of Chanticleer, as shown by a plat thereof made by R. K. Campbell, dated August 30, 1965, and recorded in the R. M. C. Office for Greenville County in Plat Book "JJJ" at page 71; and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the north side of Chapman Road at the joint front corners of Lots 3 and 2 and running along said lot lines thence N12-17E 183.8 feet to an iron pin; thence turning and running along the rear lot line of Lot 2 S79-48E 125 feet to an iron pin; thence running along the rear lot line of Lot 1 S 79-48E 115 feet to an iron pin; thence turning and running along the side lot line of Lot 1 S9-12-W 187.1 feet to an iron pin on the north side of Chapman Road; thence turning and running along the north side of Chapman Road N77-31W 125 feet to an iron pin at the joint front corners of Lots 1 and 2; thence continuing along Chapman Road N77-31W 92.4 feet to an iron pin; thence continuing along Chapman Road N87-26W 32.6 feet to an iron pin at the point of beginning.
