ALL that lot of land with improvements lying on the Southern side of Buxton Court in Greenville County, South Carolina, being shown as Lot No. 9 on a Plat of EDGEWORTH, made by Piedmont Engineers and Architects, dated October 15, 1965, recorded in the RMC Office for Greenville County, S. C., in Plat Book LLL, page 113, and having according to said plat, the following metes and bounds, to wit:
